WORKFORCE AND WAGES *The Best People at the Right Costs*

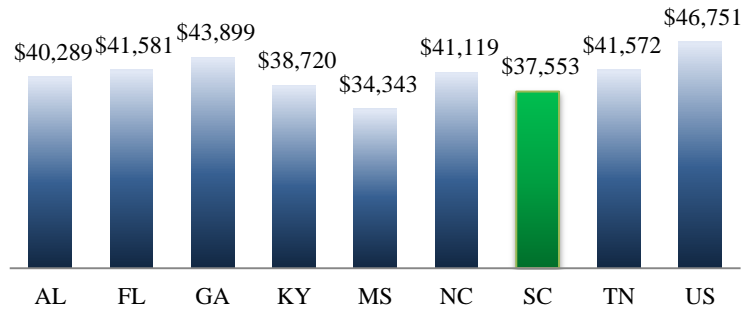
South Carolina is the nation's 10th fastest growing state, increasing in population by 16.6 percent between 2000 and 2011; higher than national rate of 10.7 percent.

During the period from 2000 to 2011, the South Carolina labor force grew 8.5 percent; more than national growth rate of 7.7 percent.

Employers in South Carolina have the right to operate their businesses and manage their workforce free of union influence. As a right-to-work state, South Carolina has the 2nd lowest unionization rate in the country. Only 2.9 percent of employees of private firms were covered by unions in 2011.

Annual Average Wages for Southeastern States In 2010

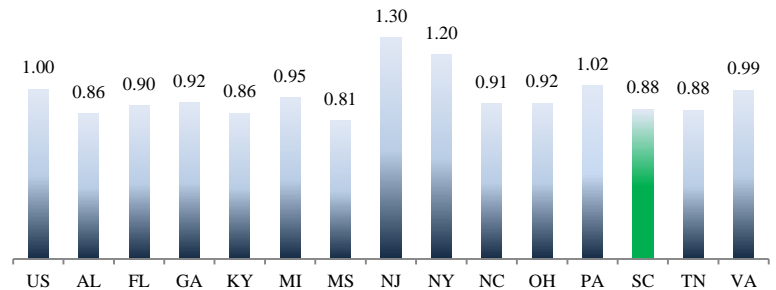


COST OF LIVING *Providing More Buying Power*

The annual cost of living index which compares all states, metropolitan areas, and counties in the United States for 2009 shows that the cost of living in South Carolina cost is 12 percent less than the national average and is the 10th lowest in the nation.

South Carolina's effective purchase power is \$1.14, which means the average value of \$1 across the nation can purchase \$1.14 worth of goods and services in South Carolina.

Cost of Living Index by State (US=1.00), 2009

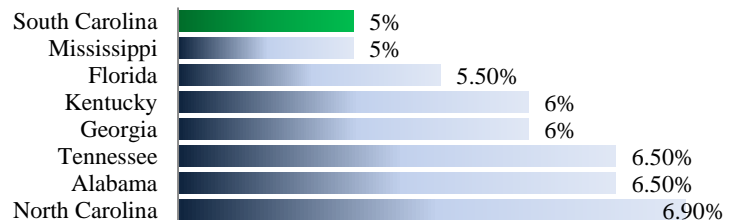


LOW TAXES *Maximizing a Business's Bottom Line*

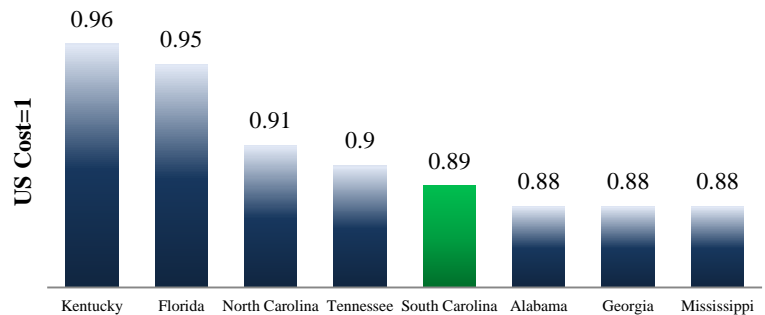
REAL ESTATE *Providing Lower Operating Costs*

Construction costs in South Carolina are the 6th lowest in the Nation and the 4th lowest in the Southeast. The cost in South Carolina is 11 percent below the United State average for Class A office facilities.

LOW UTILITY COSTS *Reliable Productivity and Energizing Profits*

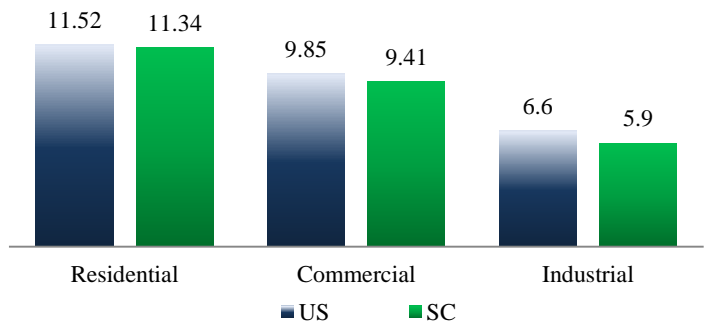
Business-friendly regulations and smart investments in energy infrastructure give South Carolina the region's most affordable power costs. Industrial power costs in the state average only 5.9 cents per kilowatt hour, the lowest in the Southeast. The average South Carolina industrial rate is among the lowest in the nation and 11 percent less than the national average of 6.6 cents per kilowatt hour.

Compared with other Southeastern states, South Carolina offers very low rates for natural gas to industrial users. The average price in 2011 was \$5.6 per thousand cubic feet, lower than the average industrial rates in Georgia, North Carolina, Alabama, Tennessee and Florida.
